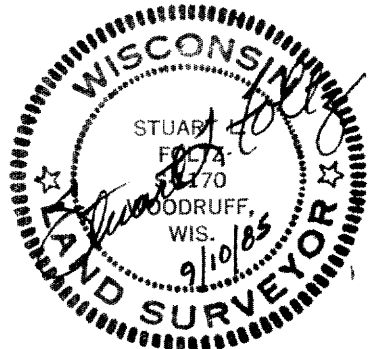
A parcel of land in the SE 1/4 of the NE 1/4, Section 15, Township 37 North, Range 5 East, Little Rice Township, Oneida County, Wisconsin, more particularly described as follows:  
 Commencing at the Section Corner to Sections 10, 11, 14 and 15, marked by an iron pipe, witnessed by a 13" Elm bearing N7°W, 14.6 feet; thence S2°23'00"W, 1312.20 feet to the north-east corner of the SE 1/4 of the NE 1/4, a 1/16th Corner, marked by an iron pipe, witnessed by a 10" White Pine (dead) bearing S17°W, 41.4 feet; thence N84°31'00"W, 33.46 feet along the north line of the SE 1/4 of the NE 1/4 to the place of beginning, marked by a 1" iron pipe.  
 Thence S35°43'00"W, 52.23 feet to a 1" iron pipe on the northeasterly right-of-way line of Willow Dam Road; thence N54°17'00"W, 33.00 feet along said right-of-way line to a 1" iron pipe; thence N35°43'00"E, 33.00 feet to a 1" iron pipe on the north line of the SE 1/4 of the NE 1/4; thence S84°31'00"E, 38.20 feet to the place of beginning.  
 Said parcel of land contains 1407 square feet.  
 Subject to any easements, reservations, or rights-of-way of record or of use, and to a perpetual easement for public utilities.
