**Description**

Part of Government Lot 1, Section 17, Township 38 North, Range 7 East, town of Lake Tomahawk, Oneida County, Wisconsin shown on a survey map by Survey North, LLC of Wisconsin with a Job No. of 12R013 dated the 13th Day of September, 2012 and more particularly described as follows:

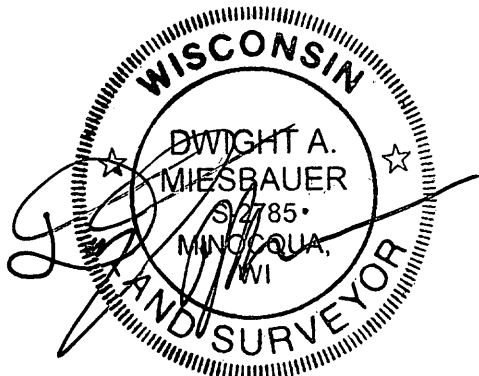
Commencing at a Meander Corner on the North Line of said Section; thence South 6° 04' 17" East, a distance of 739.08 feet to a Concrete Monument near the Southerly shore of Big Carr Lake, said point being the POINT OF BEGINNING.

Thence meandering along said lake shore South 53° 27' 10" East, a distance of 118.94 feet to a 3/4" Iron Pipe on the Westerly line of Lot -1- of the Plat of Tappa Wingo; thence leaving said meander South 1° 46' 24" West along the said Westerly line, a distance of 155.88 feet to a 1.7" Iron Pipe on the Northerly right-of-way fo the Town Road of Tappa Win Drive; thence leaving said Westerly line South 39° 23' 14" West along said Northerly right-of-way, a distance of 60.16 feet to a 2.4" Iron Pipe; thence continuing along said right-of-way South 71° 07' 34" West, a distance of 65.59 feet to a 2.4" Iron Pipe on the Westerly line of Government Lot -1- per the Plat of Tappa Wingo; thence leaving said Northerly right-of-way North 1° 51' 00" East along said Government Lot line, a distance of 294.49 feet to the POINT OF BEGINNING.

Including all those lands lying between the above described meander line and the water's edge of Big Carr Lake

Said described tract containing 0.56 acres (24341.0 square feet), more or less.
