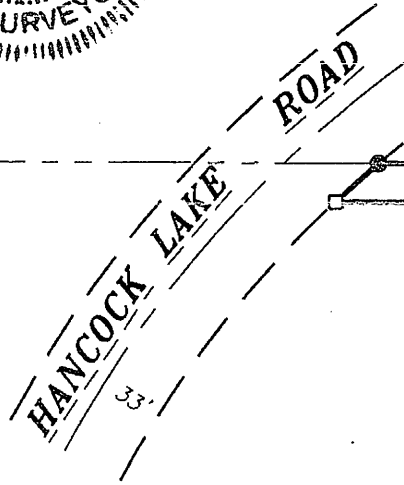


BEARINGS REFERENCED TO THE

I, TIMOTHY G. VREELAND, REGISTERED PROFESSIONAL LAND SURVEYOR, DO HEREBY CERTIFY THAT AT THE DIRECTION OF DAN PREGONT, I SURVEYED AND MAPPED THE 20 FOOT EASEMENT ACROSS THE NORTH 20 FEET OF PART OF THE SW1/4 SW1/4 OF SECTION 16, TOWNSHIP 36 NORTH, RANGE 7 EAST, TOWN OF WOODBORO, ONEIDA COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SAID SECTION 16; THENCE N 0°56'55\" W ALONG THE WEST LINE OF THE SOUTHWEST QUARTER 1333.07 FEET TO THE NORTHWEST CORNER OF THE SW1/4 SW1/4; THENCE S 88°55'02\" E ALONG THE NORTH LINE OF THE SW1/4 SW1/4 752.38 FEET TO THE EAST LINE OF HANCOCK LAKE ROAD AND TO THE POINT OF BEGINNING; THENCE CONTINUING S 88°55'02\" E 571.86 FEET TO THE NORTHEAST CORNER OF THE SW1/4 SW1/4; THENCE S 0°26'28\" E ALONG THE EAST LINE OF THE SW1/4 SW1/4 20.01 FEET; THENCE N 88°55'02\" W PARALLEL TO THE NORTH LINE OF THE SW1/4 SW1/4 594.89 FEET TO THE EAST LINE OF HANCOCK LAKE ROAD; THENCE 30.11 FEET ALONG THE ARC OF A CURVE CONCAVE TO THE EAST WHOSE RADIUS IS 558.82 FEET, WHOSE CENTRAL ANGLE IS 3°05'13\" AND WHOSE CHORD BEARS N 49°27'05\" E 30.11 FEET TO THE POINT OF BEGINNING. SUBJECT TO ALL EASEMENTS, RESTRICTIONS AND RIGHTS OF WAY OF RECORD AND USE.
