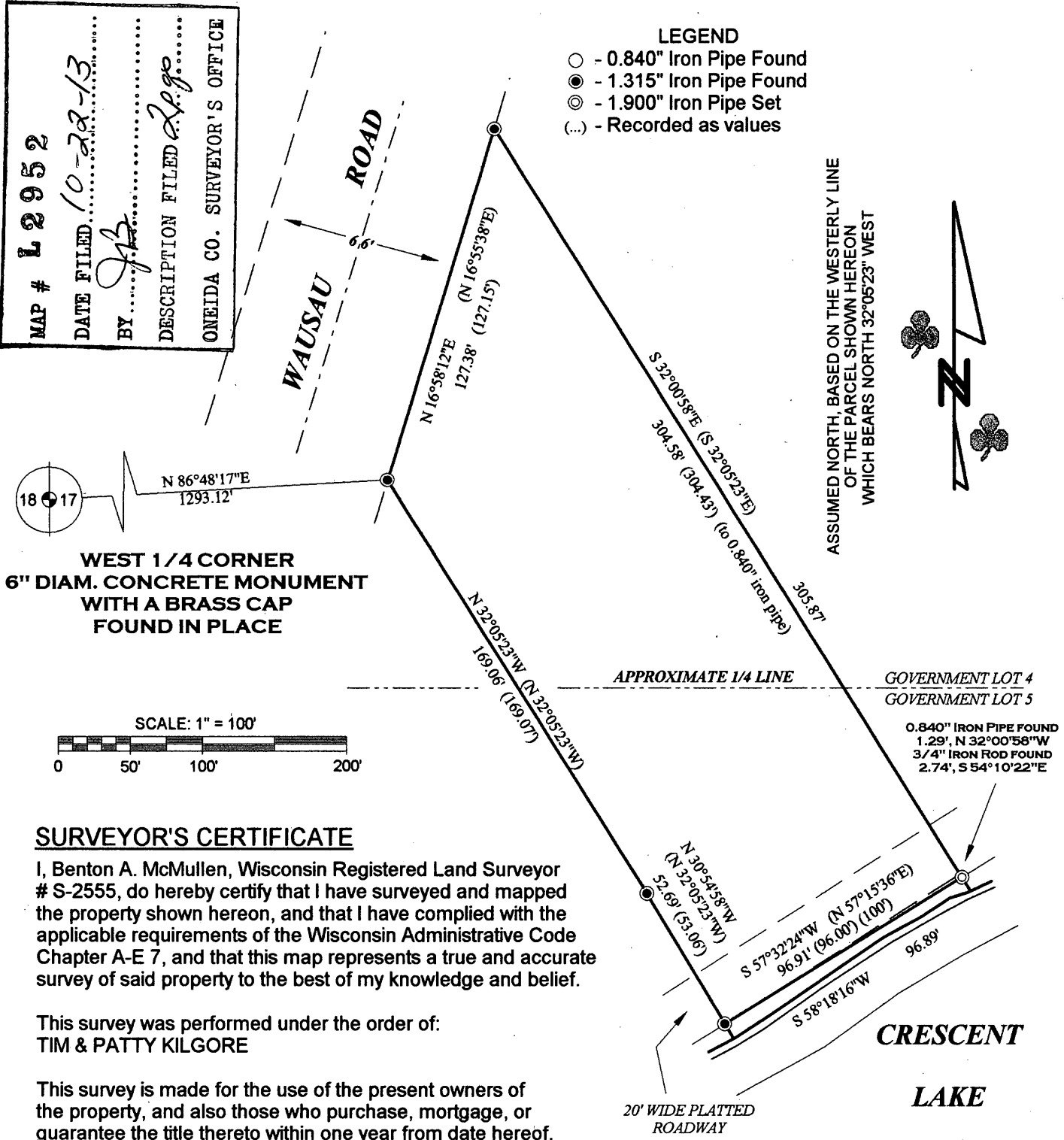

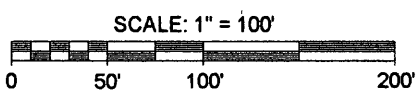

EXTERIOR DESCRIPTION (LOT 18 OF CRESENT LAKE SUBDIVISION AND THE LAND LYING BETWEEN LOT 18 AND WAUSAU ROAD)

Part of Government Lots 4 & 5, Section 17, Township 36 North, Range 8 East, Town of Crescent, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 7th day of October, 2013 with a job number of 213048 and more particularly described as follows:

Commencing at the west 1/4 corner of said section marked by a 6" diameter concrete monument with a brass cap; thence North 86° 48' 17" East, a distance of 1293.12 feet to a 1.315" iron pipe on the easterly right-of-way of Wausau Road, said point being the POINT OF BEGINNING.

Thence along said right-of-way North 16° 58' 12" East, a distance of 127.38 feet to a 1.315" iron pipe; thence leaving said right-of-way South 32° 00' 58" East, a distance of 305.87 feet to a 1.900" iron pipe near the shore of Crescent Lake; thence meandering along said lake South 58° 18' 16" West, a distance of 96.89 feet to a 1.315" iron pipe; thence leaving said shore North 30° 54' 58" West, a distance of 52.69 feet to a 1.315" iron pipe; thence North 32° 05' 23" West, a distance of 169.06 feet to the POINT OF BEGINNING.

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands lying between the above described meander line and the water's edge of Crescent Lake.

NOTE: The description above may not reflect current ownership because this description contains lands in both government lots 4 and 5. In contrast, the current description recorded at the Oneida County Register of Deeds office in document numbers 490075, 490076 and 591581 refer to lands only in government lot 5. It is suggested that the owner get a new description recorded that reflects current ownership.
