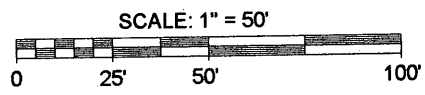

**EXTERIOR DESCRIPTION**

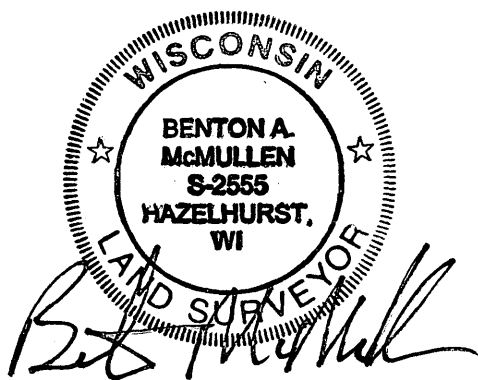
Lot 14 of the Plat of Manitou Park Clawson's Second Addition and Unplatted Lands all in government lot 1, Section 23, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 25th day of April, 2014 with a job number of 214006 and previously described in document number 733970 as recorded in the Oneida County Register of Deeds office and more particularly described as follows:

Commencing at the meander corner between sections 14 and 23 by the easterly shore of Minocqua Lake marked by an Oneida County Aluminum Monument; thence South 47° 40' 31" East (Assumed north, based on the westerly line of said lot 14 which bears North 9° 10' 38" East), a distance of 708.77' to a 1.315" iron pipe; thence South 80° 47' 30" East, a distance of 106.14 feet to a 1.315" iron pipe, said point being the POINT OF BEGINNING

Thence South 80° 30' 15" East, a distance of 95.17 feet to a 4" X 4" concrete monument; thence South 8° 07' 02" West, a distance of 252.05 feet to a 1.315" iron pipe near the shore of Minocqua Lake; thence meandering along said lake shore North 83° 20' 29" West, a distance of 99.92 feet to a 1.315" iron pipe; thence leaving said lake shore North 9° 10' 38" East, a distance of 256.93 feet to the POINT OF BEGINNING.

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands lying between the above described meander line and the water's edge of Minocqua Lake.
