

Lot 4 of HENRY C. PAYNE TRUSTEE'S SECOND ADDITION Being in GOVERNMENT LOT 4 SECTION 14, TOWNSHIP 39 NORTH, RANGE 6 EAST Town of Minocqua Oneida County, Wisconsin

EXTERIOR DESCRIPTION

Lot 4 of the Henry C. Payne Trustee's Second Addition being in Government Lot 4, Section 14, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 10th day of March, 2016 with a job number of 216010 and previously described in document number 409318 as recorded at the Oneida County Register of Deeds office and more particularly described as follows:

Commencing at the North 1/4 corner marked by an aluminum monument; thence South 64° 18' 46" West (Assumed North based on the west line of the parcel described herein which bears North 09° 09' 34" West) for a distance of 1868.86 feet to a 1.050" iron pipe by the southerly shore of Minocqua Lake; thence meandering along said shore South 79° 41' 23" West for a distance of 40.03 feet to a 1.050" iron pipe, said point being the POINT OF BEGINNING.

Thence leaving said meander line South 09° 09' 16" East for a distance of 223.76 feet to a point on the northerly right-of-way of Lakeshore Drive; thence along said right-of-way South 81° 45' 23" West for a distance of 39.73 feet to a 1.050" iron pipe; thence leaving said right-of-way North 09° 09' 34" West for a distance of 227.65 feet to a 1.050" iron pipe near said lake shore; thence meandering along said lake shore North 87° 20' 17" East for a distance of 40.00 feet to the POINT OF BEGINNING,

Said described tract having an area of 9,998 Sq. Feet or 0.24 Acres, more or less.

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands lying between the above described meander line and the water's edge of Minocqua Lake.


