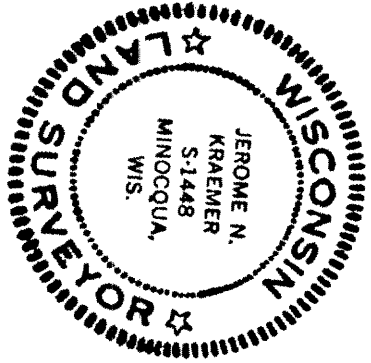
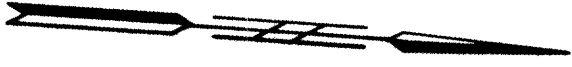

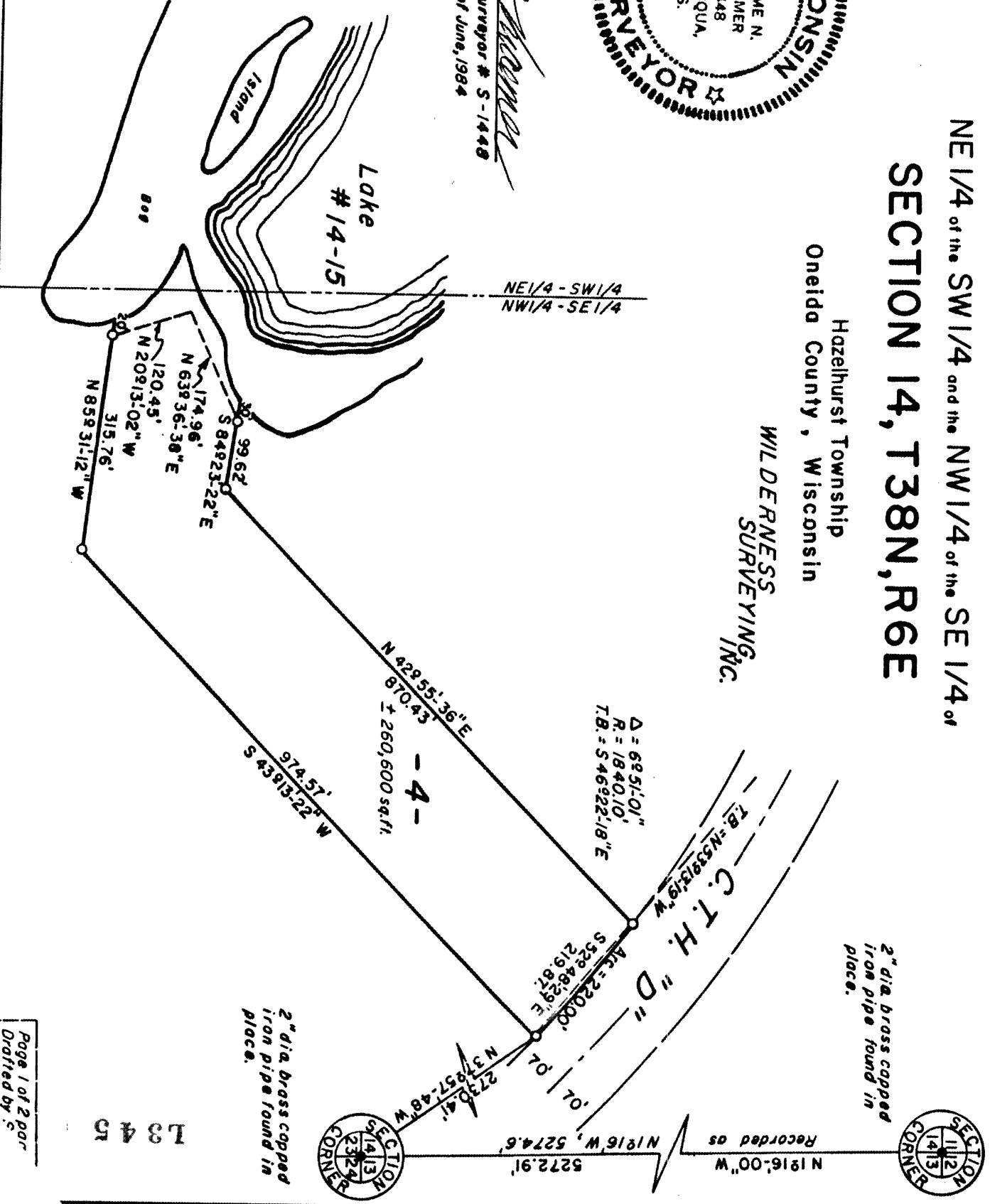

SURVEYOR'S CERTIFICATE

I, JEROME N. KRAEMER, Registered Land Surveyor No. S-1448, hereby certify that by the direction of EDWIN W. HUNTER, I have surveyed and mapped Lot 4 which is represented by this Certified Survey Map; that the exterior boundary of the parcel of land surveyed and mapped is described as follows:

Lot "4", being a part of the Northeast one-quarter of the Southwest one-quarter (NE-1/4 SW-1/4) and part of the Northwest one-quarter of the Southeast one-quarter (NW-1/4 SE-1/4), Section 14, T38N, R6E, Hazelhurst Township, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the southeast corner of Section 14, marked by a 2" diameter brass-capped iron pipe; thence N37°-57'-48"W, 2730.41 feet to the place of beginning marked by an iron pipe on the southwesterly right-of-way line of County Trunk Highway "D".

Thence S43°-13'-22"W, 974.57 feet to an iron pipe; thence N85°-31'-12"W, 315.76 feet to an iron pipe near the easterly shore of Lake #14-15; thence meandering along the shore of Lake #14-15 N20°-13'-02"W, 120.45 feet and N63°-36'-38"E, 174.96 feet to an iron pipe; thence S84°-23'-22"E, 99.62 feet to an iron pipe; thence N42°-55'-36"E, 870.43 feet to an iron pipe on the southwesterly right-of-way line of County Trunk Highway "D"; thence along the southwesterly right-of-way line of County Trunk Highway "D", along the arc of a curve concave southwesterly, having a radius of 1840.10 feet and whose chord bears S52°-48'-29"E, 219.87 feet to the place of beginning.

Including also all lands lying between the meander line and the shore of Lake #14-15.

That this Certified Survey Map is a correct representation of the exterior boundary surveyed and described; that I have fully complied with the provisions of Chapter 236.34 of the Wisconsin Statutes and the provisions of the Oneida County Zoning and Shorelands Protection Ordinance in surveying and mapping same.
