Town of Woodruff Oneida County, Wisconsin

Parcel 1, being part of Government Lot 1, Section 1, Township 39 North, Range 6 East, Town of Woodruff, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the meander corner between Sections 1 and 2 near the southerly shore of Woodland Lake, marked by an Oneida County aluminum monument (see U.S.P.L.S. monument record); thence S2°09'39E along the west line of said Section 1, a distance of 247.38 feet to the point of beginning marked by an axle shaft.

Thence N87°47′54″E, 787.56 feet to a point on the westerly right-of-way line of Balsam Street, marked by a 1-3/16″ iron rod; thence S4°19′21″W along said right-of-way line, 335.60 feet to a point marked by a 1-3/16″ iron rod; thence S3°08′49″W, along siad right-of-way line, 162.94 feet to a point marked by a 1-3/16″ iron rod; thence S20°23′33″W along said right-of-way line, 108.33 feet to a point on the northeasterly right-of-way line of State Trunk Highway "47″, marked by a 3/4″ iron rod; thence N73°03′11″W along the northeasterly right-of-way line of State Trunk Highway "47″, a distance of 733.45 feet to a point on the west line of said Section 1, marked by a 3/4″ iron rod; thence N2°09′39″W along the west line of said Section 1, a distance of 355.09 feet to the point of beginning.

Described parcel contains 364,695 square feet.(8.37 acres).
