- 6 Apr 1920 \$2K raised for Hwy; fund: \$1K each for E end and W end. Wm. Dietrich to be road Supt. in W end. John Anderson-E end. \$750 to be raised for Cnty. Aid on the Twn. and Cntt. Rd., N betw. S35-36. 23-24, 14-13, & 12-1 T37R5E.
- 5 Apr 1921 Ann. Mtng. @Kelly School House. \$300 to be used to build rd. betw: SW of NW &NW of SW S32 T36 R5E. \$200 to be used for rd. for Wm. Barth.

1 Apr 1924 Mot. & carr. \$350 for Emmerich rd. on N1/8 line in S13-36-5E running W to be 3 rods wide. Petition RR to reinstate crossing @ McCord on 1/8 line betw. SE of SE & SW of SE S31 T36 R5.

7 Apr 1925 Mot. & carr. spend \$150 on rd. start @ the C Rozell corner & run W ½ mi. N. Spend \$50 on Wm. Borth rd.

6 Apr 1926 \$300 for bridge fund to raise present bridge on ¼ line in S 13-36-5E known as Emmerich rd. to raise bridge 10 ft. higher then it is now, to cut hill on W side, & E side as Bd. may direct.

(Mot. Passed). Moved & 2nd Twn. keep all rds. in Twn. plowed and when necessary in winter where anyone is living. Passed

Mot. & 2nd. Twn. to grade all rds. as necessary. Passed.

Mot.& 2nd to raise \$500 for a rd. to be built in T37-5E to the dam site at Flowage. Rd. per description on Hwy. petition attached. Carried.

2 Apr 29 Mot. & 2nd that Twn. keep all Twn. Rds. that can be plowed in Twn. snow plowed when necess. where settlers are living. Carried.

2 Apr 1946 Motion to grade and oil Willow Dam Rd. Carried

21OCT 1948 Beg. 1/8 post betw. Lot 1 Sec 3 and Lot 1 Sec 4 running due south approx. 70 rods thence in a west. direction approx. 600 ft. thence So to the Northerly shore of Burrows Lake. Dist. of about 250 ft.

Some of the taxpayers petit. Board about this road. NO ACTION TAKEN!

21Dec 1948 Notify owners of mtng. Jan 10, re: road N side of Burrows Lake.

- 10 Jan 1949 Mtng. Called to order at Beachwood Resort. Chairman Clements.
 - Results: Wait for annual Town Mtng.! (NO action taken at ann. Mtng.)

Conserv. Comm. gave forestry comm. authoriz. to use forestry \$ to put in concrete culverts to replace "wood bridge" & otherwise to re-vamp the fire lane rds.

5 Apr 1949 Moved by Frank Bassett that fire lanes do not be taken over by the town. Carried.

Motion & carry to pay WVIC \$465.00 for "Dam Rd."

- 29 Sep 1957Mot. & 2nd: buy culvert for Merlin road.

- 14 Jun 1960 Antone Thorpe petit. Twn. Bd. to put in rd. from public landing at Bass Lake to his west line, approx. 50 yds. Mot. & 2nd to lay out right of way. Twn. To meet at property 20 Jun 1960. Mot. & 2nd to lay out road. Petit. was signed by 12 people: Minnie/James Rozell; Algot/Ethel Lundgren; Carl/Metrice Felser; Annie/Chas. Mason; Antone/Lillie Thorpe.
- 22 June 1960 Mot. & 2nd. Put a Twn. rd. in Burrows Lk rd. approx 70 rods circling twn. dump. NW NW S12 T36 R5 Rd. to be 4 rods wide, dirt surface. Rd. easement bought from Harlan rice for \$50.00
- 24 Aug 1960 Spec. Twn. mtng. motion passed to borrow money for Bass Lk. Rd. const. from boat landing to Thorpe land, and same for Little Rice bridge (on Kelly Rd.)
- 8 Sep 1960 OK to borrow \$6000. for const. of Little Rice River bridge on Kelley rd & to continue the Bass Lake rd from pub. landing to the Thorpe land.

13 July 1961 Future road to be known as The Kelly Rd which junctions with the L. Rice dam rd, and the Kelly Rd as known today. SW ¼ SW ¼ 24-36. Rd. to be completed at Kelly's expense.

14 Sep 1961 Twn. accepts Twn. Rd. S16-36-5 NW of NW-Bass Lk. rd. about 130 rods long. Spec. Twn. Mtng. to be 10 Feb 1962 re: new rd. from "Y" to Burrows Lk. Rd.

31 July 1961 Voted to let Twn. Chairman finish Verberg Rd. as he sees fit.

14 Aug 1990 Survey for rd. known as Killarney Bay lane, loc: S14&S 23 T36N R5E approved by Twn Bd. contingent on any decision by Plann. & Zoning Dept. Pittlick & Wick bid \$7500/mi. to chip & tar portion of Willow D. Rd., Musson/Rhinel. bid \$8,060 to grind pavement on all of Cedar Falls Rd. & 600 ft. on Willow D. Rd.

9 Jul 1991 Oneida Cnty. Hwy Dept. crushed and hauled 550 yds of gravel to Twn. for \$8.22 per yd. (from Rocky Run pit). County Forest Dept. gave Twn. LR permission to open new gravel pit in Sec 29 T36N R5E.

13 Aug 1991 Twn. told cost for new blacktop on Willow Dam Rd.-\$5235.75

12 Nov 1991 Twn. Bd. agreed: \$50 to plow snow on Old 8 on portion passing thru
Twn. of Wilson

12 Oct. 1993 Route 51 was extended to Swamp Lake Rd. so big increase in traffic. Swamp Lake rd. needs repairs!

1994 Multiple mtngs. To discuss repairs of twn. Rds. Bids let-BUT NO REFERENCE on WHAT ROADS!

15 Sept. 1994 Shows total cost of new roads & who was paid BUT no roads shown

10 Oct 1995 Charge Twn. of Wilson \$50 each time to plow snow & \$75 each time we grade.

13 May 1997 New signs will be ordered & put up: Koffke, Patricia, Maple Ln., Smokey Ln., Modern, Bishop Ln, Shirley Glenn, Killarney Bay and Smokewood.

9 Sep 1997 "Cut down hill @ "Y" and Swamp Lake rd.

14 Oct 1997 Will cost \$50,000 for overlay on Willow D. rd. bridge. Have 4 years to do

9 Dec 1997 Howard Griffiths & Ray Borth asked why Smokey Ln. not plowed? Ans.: Twn. does not maintain easement rds.

10 Feb 1998 Crackfilling of rds. approved:same price as least yr. \$4999.

14 Jun 1998 Al Hirn wanted residents to pay Twn. to plow rds. Board said NO. The rds. stay easement rds: Haven Dr(Bohn Dr), Maple Ln, Smokey Ln., Koffke Dr.

July 1998 Bruce Jensen presented petition to discuss easement rds.(Smokey Ln.) Chairman said NO.

- 13 Oct 1998 Tom Doberstein presented petit. to Board to snowplow: Smokey Ln, Maple Ln, Koffke Dr. & Bohn Rd. Bowers agreed to meet with people on Smokey Ln. Other roads were No problem. If twn. can't get down rd-no plowing.
- 10 Nov 1998 Resol. #98-03 Plowing of easement rds. Unanimously passed.
- 8 Dec 1998 Bd. rescinded Res.#98-01 pertain. to Little Rice R. maintaining Koffke Dr.
- 12 Jan 1999 Joe Mayes(Chairmn.): we will be blacktop. about 1 mile of road sometime this yr.: Kelly Fire Ln. & Patricia Ln. to Kelly Dam Rd.
- 23 Feb 1999blacktop: Kelly Dam Rd to Patrica about \$40K, Brown Rd. to Killarney about \$70K, Stone Cr \$12K. Rozell Rd,. belongs to Cnty Forest Dept.
- 9 Mar 1999 5.7 mi. to be blacktop:Brown rd. will be dropped if not enough \$. Kilarney Bay Rd. & Kiech for sure, ½ of Stone Cr., Burrows Lk Rd. to Gobbler. Kelly Fire Ln. to Patricia.
- 8 Jun 1999 Reso. #99-01 to support exten. of 4 lane Hwy on 51 from Hwy 8 to Hazelh.
- 12 Oct 1999 New rd. going in off Hwy "Y" by old 8 will be named Sturgis.
- 9 Nov 1999 rds to be blacktop: pt. of Brown Rd, about ½ mi Woodsmoke, ¼ mi. old 8
- 8 Feb 2000 Follow. to be blacktop. this yr.: 1/53 mi. Brown Rd., .5 mi old hwy8, .3 mi Willow D. Rd.& parking lot in front of Fire Dept.
- 8 Aug 2000 Twn/Wilson: each pass (snow plow.) to be \$100.
- 12 Dec 2000 Kevin Asher (Beachwood) has septic problem agreed to repair any rd. damage in the repair of same.
- 13 Feb 2001 Twn. will not be plowing easement rd off River Rd because it is easement or they can pay \$250 per year.
- 8 May 2001 culvert was replaced on Kelly Fire Ln. Blacktop: 1.46 mi Kelly rd to be dropped for lack of \$.
- 24 May 2001Blacktop: Rice Rd, Kelch Rd, Kelly Dam, Younker Dr., Woodsmith Dr., Woodsmoke Ct.

12 Jun 2001 Approv. 2 new rds: Old 8 lane, first ½ of Old 8

10 Jul 2001 Riedel new rd. off of Little r. Dam rd. to be an easement rd.

Aug 2001 Culvert to be put in on willow Dam Rd.

Sep 2001 For Rice Rd. extension, each person to pay \$30 per person.

9 Apr 2002 Kilarney was an easement rd. & NOT to be blacktopped.

14 May 2002 Someone asked why the cutting along side of rd. was so wide. Ans.:

33 ft from center line of road is Towns.

July 2002 Keach Rd. to be Feathered Fish Ln.

Oct 2002 Twn. to maintain Killarney & Helen Ln. as Town Rds. Twn. to keep as town Rd. (W Killarney). Twn. to plow Helen Ln. It will remain easement rd.

11 Mar 2003 Little Rice bridge to be restarted Mar. 17

8 Apr 2003 Arnott is now plowing for Twn. Of Wilson.

13 May 2003 1st overlay on Willow D. Rd. south to be done.

Aug 2003 (Boomba & Killarney should be done in a few wks.)? Paving Willow D. Rd. is done for this yr.

Sep 2003 Both bridges are now complete. Willow Dam bridge may have some delay.

Oct 2003 Old bus. bridge report: Killarney & Boomba are done. Willow D. to be done in 2005. Some historians feel it is some sort of keepsake.

9 Dec 2003 Burrows Lk. Rd to be asphalted in 2004. Willow Dam rd in 2005-6.

Apr 2004 Burrows Lk. Rd. to be done to near Brown Creek Rd. and West on old 8 by Boomba Bar. Crack filling to be done especially on Bishop Ln.

6 July 2004 Bridge on Willow Dam Rd.: Historical Soc. seems to be prolonging it, while bridge becomes more unstable.

10 Aug 2004 Bridge(W D Rd.) may start in 2005

14 Dec 2004 W. D. bridge will close Oct 2005
