Your letter of May 20th，1926， addressed to Judge Sheridan，in reference to the construction of a road across lot 3 ，section 8－39－ 11，has been referred to me for attention．

We are handling the foreclosure of this farm under trust mortgage．I do not believe that there is anyone at the present time who has authority to grant a release for the strip of land which you wish to use for this road．The plaintiff in the foreclosure action is merely a trustee for bondholders and would not have authority to release any of the mortgaged premises．The owners of the lend in fee are all foreclosed by the judgment，so that I believe you will have to wait until the premises are sold under the foreclosure judgment before finding any one responsible and with authority to give a re－ lease．If the premises are condemned thru legal proceedings，I suppose that we can have no objection thereto，and I see no way of avoiding the necessity of going thru these proceedings，al tho we would be very glad to help you as far as possible．
